HONORING ROBERT & MARGARET ZAK

When Bob and Margaret Zak learned they would be honored by United Way this year, their first response was surprise, followed by reflections on the contributions of past honorees (but not before noting, “You finally got to the Z’s!”). Their self-effacing nature belies tremendous, lifelong dedication to Erie County through philanthropy and volunteerism, which is why they have been named the United Way Tocqueville Society Philanthropists of the Year.

Bob and Margaret learned the value of philanthropy from an early age. Their parents were active community members and also demonstrated commitment to community through their professions. Bob’s father is a retired City of Buffalo police officer, and Margaret’s mother was a social worker for Erie County.

Bob and Margaret met in high school and have been together since. They both attended the University at Buffalo where Bob earned Bachelor of Science and MBA degrees in accounting and economics, while Margaret earned a Bachelor of Science degree in physical therapy. Their three sons, Dan, Michael and Kevin, attended Canisius High School (Bob’s alma mater), where they also learned the value of giving back to the community.

Bob’s career began in public accounting and led him into the insurance industry. He is currently president and chief executive officer of Merchants Mutual Insurance Company, and is the organization’s primary representative to industry and agent trade organizations, community and civic organizations, government regulators, and insurance company rating organizations. Prior to his appointment as president and CEO in 1995, Bob was senior vice president and chief financial officer.

It was during Bob’s time at Merchants that he first got involved with the United Way. He started as chair of the insurance division of the annual campaign. From there Bob quickly moved up the ranks of leadership. He has served two terms on the board of directors, included three years as board chair. Currently he chairs the Endowment and Planned Giving Committee.

Bob also found time to hold board positions at other organizations in the community, including the 100 Club of Buffalo, Invest Buffalo Niagara (formerly Buffalo Niagara Enterprise), the Buffalo State College Council, University at Buffalo School of Management Dean’s Advisory Council, Canisius High School, and Kaleida Health.

Margaret worked for 30 years as a pediatric physical therapist for Associated Physical & Occupational Therapists. She worked part-time while raising their three sons, and also found time to volunteer in the community. She is director and secretary of the board for The Children’s Guild Foundation, a volunteer baby rocker at Children’s Hospital Neonatal Intensive Care Unit, and a past director of Upstate New York Transplant Services (UNYTS).

When asked why they prioritize giving back to their community, they said, “We have been blessed in a number of ways—a beautiful family, amazing friends and good professions to name a few. We have the time and the resources and we believe it is the responsibility of those who have been blessed as we have to give back to their community.”

It is because of this sentiment and so much more that we are proud to honor Robert and Margaret Zak as the United Way Tocqueville Society Philanthropists of the Year.

Program investments represent only a portion of the organization's total investment in improving quality of life in Erie County. In all, United Way invested more than \$19M into our community last year, including:

- \$4,587,000 in 107 programs and services, including special services such as American Red Cross Disaster Relief Services, 2-1-1 WNY information and referral call center, and Labor Emergency Services. This funding is made with discretionary funds.
- \$3,189,000 in grant funding awarded to partner agencies in the community
- \$2,832,000 in United Way led initiatives, such as Creating Assets, Savings and Hope (CASH); Closing the Gap; and Erie/Niagara Birth to 8 Coalition
- \$1,703,000 in bequests, endowment donations and investment income to support our work into the future
